eHI Leads Pledge on Digital Health Equity

Washington, DC – November 4, 2021 – Today at the virtual Digital Health Equity Summit, the eHealth Initiative (eHI) released the Digital Health Equity Pledge.

Designed to ensure that powerful digital health technologies do not exacerbate existing biases, the Pledge centers on commitments from organizations in four main areas: accessibility; diversity; respect; and public policy. Highlighting equity issues that are specific to digital health, the Pledge calls for increased focus and responsibility from companies to address those issues by following the guidelines and working to reach its ambitious goals.

"eHI is proud to lead the Digital Health Equity Pledge," said Jen Covich Bordenick, CEO, eHI. "We have been at the forefront of convening healthcare leaders to discuss barriers and address inequities in the current system and how technology and data can be leveraged in this on-going work.
